

## #MOVEWITHMLB60 SWEEPSTAKES (THE “SWEEPSTAKES”)

### OFFICIAL RULES

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ODDS OF WINNING WILL DEPEND ON THE TOTAL NUMBER OF ELIGIBLE ENTRIES RECEIVED DURING EACH APPLICABLE ENTRY PERIOD. VOID OUTSIDE OF THE UNITED KINGDOM AND WHERE PROHIBITED BY LAW. ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION.**

**ELIGIBILITY:** The Sweepstakes is open only to legal residents of the United Kingdom who are eighteen (18) years of age or older at the time of entry. Employees, officers, and directors, and their immediate family members (spouse, parent, child, sibling, and their respective spouses, regardless of where they reside) and members of the same household (whether or not related), of Major League Baseball Europe, Ltd. (“**Sponsor**”), the other MLB Entities and each of their respective parents, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers, advertising and promotion agencies, and any other entity associated with the Sweepstakes are not eligible to participate or win a prize. “**MLB Entities**” means the Office of the Commissioner of Baseball (“**BOC**”), its Bureaus, Committees, Subcommittees and Councils, MLB Advanced Media, L.P. The Sweepstakes is subject to all applicable laws, rules, and regulations. Void outside the United Kingdom and where prohibited or restricted by law, rule, or regulation.

**HOW TO ENTER:** The Sweepstakes will feature multiple entry periods (each, an “**Entry Period**”) as set forth in the table below. The first Entry Period begins at 06:00 Greenwich Mean Time (“**GMT**”) on March 1, 2021 and the final Entry Period ends at 23:59 GMT on March 29, 2021 (the “**Sweepstakes Period**”). You may enter the Sweepstakes via Instagram or email, as described below. No other methods of entry will be accepted. Limit ten (10) entries per person/Entry Period, regardless of method of entry. - 1. Instagram Method:** To enter via Instagram, you must have a valid public (i.e., not protected) Instagram account and be a follower of @MLBEurope (the “**Sweeps IG Account**”). During an available Entry Period, the Sweeps IG Account will publish an Instagram post which invites entries into the Sweepstakes (the “**Invitation Post**”). Using your Instagram account, publish an Instagram post which complies with the instructions specified in the Invitation Post and these Official Rules and include the hashtags #movewithmlb60 and #sweepstakes in the caption of your post (“**Entry Post**”) to receive one (1) entry for the applicable Entry Period. Your Entry Post must remain publicly posted through the duration of the Sweepstakes and must comply with the Content Restrictions (as set forth below) and Instagram’s Terms of Use, available at [help.instagram.com](https://help.instagram.com). All information submitted via the Instagram platform is subject to, Instagram’s privacy policy and Instagram’s Terms of Use, available at [help.instagram.com](https://help.instagram.com). If you do not have an Instagram account, you may register for one, for free, at Instagram.com. Data and usage rates may apply to the download and use of the Instagram mobile application. The time of receipt of any Entry Post shall be the time such entry is made available to Sponsor via the Instagram platform. Any Entry Post that does not

comply with the Content Restrictions or otherwise with these Official Rules and any that are removed or hidden during the Sweepstakes Period are void. MLB provides appropriate security to safeguard your personal information. You can modify your preferences at any time, all pursuant to the Privacy Policy. You can request the modification or deletion of your personal information from MLB's records at any time. You can request a copy of your personal information held by MLB at any time. Should you have any complaints about MLB's use and storage of your personal information, you can direct them to your country's data protection authority. MLB agrees to ensure that the collection of all personal information complies with (i) all applicable laws, including without limitation, all national and local laws, corporate standards, policies, regulations, as well as the General Data Protection Regulation ("**GDPR**") (collectively "**Applicable Laws**"); (ii) the principles, guidelines, rules, and codes of conduct of self-regulatory organizations such as the Digital Advertising Alliance, the Interactive Advertising Bureau, the Direct Marketing Association, and other self-regulatory organizations to which third parties providing services, platforms, and data are bound, and any required notices and consents; and (iii) privacy disclosures and information collection requirements imposed on advertisers by targeting of media in order to comply with Applicable Laws. Where required by Applicable Laws, MLB will deploy appropriate notices and functionality to obtain authorizations and consents as required.

**RANDOM DRAWINGS; ODDS:** On or about each Drawing Date, one (1) potential winner for each of the First Prize, Second Prize, and Third Prize, as defined below, will be selected by random drawing from among all eligible entries received for the applicable Entry Period. On or about the final Drawing Date, one (1) potential winner for each of Grand Prize 1, Grand Prize 2, and Grand Prize 3, as defined below, will be selected by random drawing from among those participants who submitted an entry for all four (4) of the Entry Periods. For the avoidance of doubt, if an entrant did not submit at least one (1) entry for each of the four (4) Entry Periods (a "**Complete Set of Entries**"), such entrant will not be included in the random drawing to be considered for the Grand Prizes. Also for the avoidance of doubt, participants who are eligible to be included in the Grand Prize drawings will receive only one (1) entry into the Grand Prize drawings, regardless of the number of Complete Sets of Entries submitted. Subject to verification of eligibility and compliance with these Official Rules, the potential winners will be declared the official winners of the Sweepstakes. **Grand Prize 2:** One (1) Nintendo Switch and one (1) R.B.I. 21 video game. (ARV of Grand Prize 2: £299.99.)

**Grand Prize 3:** One (1) FitBit Versa 2 watch. (ARV of Grand Prize 3: £169.99.)

Total ARV of all prizes: £1,348.98.

**PRIZE CONDITIONS:** All prize details, including but not limited to product models, shall be determined in the sole and absolute discretion of Sponsor. Each winner is fully responsible for any and all applicable taxes, including income and withholding taxes. All costs and expenses associated with prize acceptance and use which are not specifically included in the prize descriptions above are the sole responsibility of each winner. Prizes are non-transferable and non-assignable, with no cash redemptions except at Sponsor's sole and absolute discretion. Sponsor reserves the right to substitute any prize (or any portion thereof) with a prize of comparable or greater value at its sole and absolute discretion.

**NOTIFICATION:** Each potential winner will be notified via direct message to the Instagram account used for entry, email or telephone (the "**Prize Notification**"), as determined by Sponsor. In the event that a potential winner does not respond to Prize Notification within three (3) days of the date of issuance or declines the prize for any reason, a disqualification will result, the prize will be forfeited and, at Sponsor's sole discretion and time permitting, an alternate potential winner may be randomly selected from among all remaining eligible entries. Any entry that does not comply with the foregoing, as determined in the sole discretion of Sponsor, will be disqualified.

the date of submission, or has all necessary rights and authorizations to submit the entry, including the express permission of all individuals embodied in the entry, for possible use as provided herein; (b) agrees that his/her entry does not violate MLB's Terms of Use accessible at [mlb.com/tou](http://mlb.com/tou) or infringe upon the copyright, trademark, or other intellectual property rights, or rights of privacy or publicity, of any person or entity; (c) grants to Sponsor, the other MLB Entities, and each of their respective designees the perpetual and unlimited right and license to use, license, edit, modify, duplicate, and/or create derivative works from his/her entry throughout the world and in perpetuity, including but not limited to the right for the MLB Entities to publish, display, broadcast, distribute, reproduce, perform, create derivative works from, and otherwise use and exploit the entry via the Internet, in stadium, on television, in print, and/or any other media currently existing and hereafter developed without limitation and without notice or payment of any compensation to the entrant or his/her heirs and successors: (i) on its own or as part of any audiovisual or other production; (ii) to advertise any products, programming, or services of the MLB Entities or for any other advertising, marketing, and promotional purposes and in any materials related thereto; and/or (iii) for any other purpose whatsoever; and (d) release in perpetuity the Released Parties (as defined below) from any claims, demands, losses, and liabilities of any nature arising out of or in any way connected with the entry and use thereof as permitted hereunder, including but not limited to claims of copyright or trademark infringement, false endorsement, libel, slander, defamation, or infringement of rights of publicity or privacy. Released Parties are not responsible for stolen, late, incomplete, illegible, inaccurate, misdirected, lost, misrouted, scrambled, damaged, delayed, undelivered, mutilated, postage-due, or garbled entries, transmissions, email, or mail; lost, interrupted, or unavailable network, cable, satellite, server, Internet Service Provider (ISP), wireless network, website, or other connections; availability, accessibility, miscommunications, or failures of computer, satellite, telephone, cable, or wireless transmissions or lines; computer hardware or software malfunctions, failures, or difficulties; wireless service congestion; failures or malfunctions of phones, phone lines, telephone systems, wireless towers, or cellular tower equipment; any error, omission, interruption, defect, or delay in wireless or other transmission, processing, or communication; printing, typographical, or other errors appearing within these Official Rules, in any Sweepstakes-related advertisements, or other materials; cancellation or postponement of any Major League Baseball game/event/exhibition; or any other errors, problems, or difficulties of any kind, whether human, mechanical, electronic, or other, relating to the Sweepstakes, including, without limitation, errors or difficulties which may occur in connection with administration of the Sweepstakes, processing of entries, announcement of any winner, or any Sweepstakes-related materials. Released Parties are also not responsible for any incorrect or inaccurate information, whether caused by website users (e.g., hacking) or by any equipment or programming associated with or utilized in the Sweepstakes. Released Parties are not responsible for injury or damage to entrant's or to any other person's computer and/or wireless device related to or resulting from participating in this Sweepstakes or downloading materials from or use of the Sweepstakes website. Entries generated by a script, macro, or other mechanical or automated means will be disqualified. In the event of dispute as to the identity or eligibility of any potential winner based on an Instagram account, the winning entry will be declared made by the Authorized IG Account Holder of the Instagram account used to enter the Sweepstakes, provided he/she is eligible according to these Official Rules. The "**Authorized IG Account Holder**" is defined as the natural person who is assigned to an Instagram account by Facebook, Inc. In the event of dispute as to the identity or eligibility of any potential winner based on email address, the winning entry will be declared made by the Authorized Account Holder of the email address submitted at the time of entry, provided he/she is eligible according to these Official Rules. The "**Authorized Account Holder**" is the natural person to whom the applicable ISP or other organization (such as a business or educational institution) has assigned the submitted email address for the domain associated with such email address.

#### **ARBITRATION:**

- i. The validity, construction, and enforceability of this Sweepstakes, and all matters or disputes arising under, in connection with, or related to this Sweepstakes shall be governed by the laws of London, United Kingdom without regard to its conflict of law principles, applicable to contracts entered into and performed entirely within that Country. Any controversy or claim arising out of or relating to this Sweepstakes, or the breach thereof, shall be settled by arbitration. The place of arbitration shall be London, United Kingdom. Except as may be required by law or as necessary for court proceedings authorized in this Section, neither a party nor an arbitrator may disclose the existence, content, or results of any arbitration hereunder without the prior written consent of both parties.
- ii. The arbitration shall be conducted in accordance with the International Centre for Dispute Resolution ("**ICDR**") Procedures before a single arbitrator who shall be a lawyer with at least fifteen (15) years of experience in general commercial or contractual disputes. The arbitrator shall be selected by

mutual agreement of the parties, or, if the parties cannot agree, within thirty (30) days of the date of the Notice of Arbitration, then by striking from a list of arbitrators supplied by ICDR. The language of the arbitration shall be English. The cost of the arbitration, including the arbitrators' and administrative fees, shall be borne equally by each party, and each party shall be responsible for its own expenses and attorneys' fees and costs. The arbitrator shall follow the laws of London, United Kingdom (without regard to conflicts of law rules to the extent that such rules would require the application of the laws of another jurisdiction) and the parties agreed evidentiary rules (or the ICDR applicable rules in the absence of agreement amongst the parties) in making a decision.

- iii. The arbitrator will have no authority to award punitive or other monetary damages not measured by the prevailing party's actual damages, except as may be required by statute. The arbitrator shall not award consequential damages in any arbitration initiated herein. The award of the arbitrator shall be accompanied by a reasoned opinion.
- iv. Either party also may, without waiving any remedy under this Sweepstakes, seek from any court of competent jurisdiction located in London, England, any interim or provisional relief that is necessary to protect the rights or property of that party, pending the establishment of the arbitral tribunal. Neither party shall be entitled or permitted to commence or maintain any action in a court of law with respect to any matter in dispute unless such action is authorized by this Section.
- v. A party seeking enforcement shall be entitled to an award of all reasonable costs, fees, and expenses, including attorneys' fees incurred in enforcing the award, to be paid by the party against whom enforcement is ordered.
- vi. The parties hereby waive the right to a jury trial in connection with any court proceedings authorized by this Section.
